#### Data storage period

The determination of the storage period of your personal data is in accordance with the principle of processing requirements. Your personal data will therefore only be stored for the entire period of validity of your personal access to the Orchestra Data Portal.

#### Rights of the data subject

Please note that with reference to your provided personal data, you have the following rights:

- 2. to obtain the rectification of your personal data or the limitation of the processing operations concerning you
- 3. to obtain the erasure of your personal data

- 6. to lodge a complaint with the supervisory authority
